A trust company is an institution that exists to administer trusts and estates, as well as assist in general asset management. Trust companies can act as executor, trustee or attorney for property, and can also operate as agent for those acting in these capacities. Importantly, trust companies are allowed to act as fiduciaries. This means that trust companies may take on a role, such as executor or trustee, where they are tasked with holding and managing assets for the benefit of another individual. A fiduciary owes a duty of care and of loyalty to the individual for whom they hold assets, and must always act in that individual's best interests. Because they routinely act in a fiduciary capacity, trust companies are strictly regulated.
